COMMISSIONER'S ORDER 1979/42
TOBACCO TAX ORDINANCE

Pursuant to the provisions of the Tobacco Tax Ordinance, the Commissioner of the Yukon Territory is pleased to and doth hereby order as follows:

1. That the Tobacco Tax Regulations established by Commissioner's Order 1974/331 are hereby amended by repealing Section 20 and substituting the annexed Section 20 therefor.

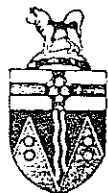

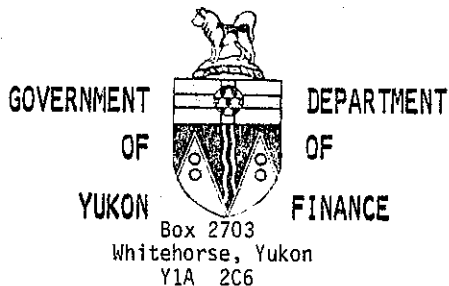

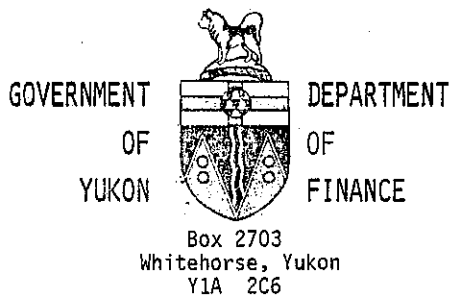
